### Terms & Conditions

I HAVE READ AND AGREE TO THE FOLLOWING: In consideration of my participation in the activities of Trust Your Guide Fly Fishing, LLC, I agree to the following Waiver and Release: I acknowledge that fishing has inherent risks, hazards, and dangers for anyone that cannot be eliminated, particularly in wilderness environments. I understand that these risks, hazards, and dangers include without limitation: 1. Water hazards and wading in the rivers, including drowning; 2. Hiking in rugged country; 3. Injuries from fishing equipment and other participants; 4. Encounters with wildlife, animals, and insects; 5. Temperature extremes; 6. Inclement weather and unavailability of immediate medical attention in the wilderness in case of injury. I understand the risks, hazards, and dangers of wade fishing, fly fishing and wading, and have had the opportunity to discuss these with Trust Your Guide Fly Fishing, LLC. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have the level of good physical conditioning, and the degree of skill and knowledge necessary for me to engage in these activities safely. I am voluntarily participating in this activity and using the services of Trust Your Guide Fly Fishing, LLC with full knowledge of the inherent risks, hazards, and dangers involved and hereby assume and accept any and all risks of injury, paralysis, or death. I release and discharge Trust Your Guide Fly Fishing, LLC, its officers, agents, contractors, and employees from any and all liability, claims, or demands for injuries which may be suffered or property damaged which may be incurred from riding in or driving a vehicle during the time of participation in the activities of Trust Your Guide Fly Fishing, LLC.
